The MPO Board must remove all remnants of the old Interstate Study from the TIP and funding priorities. The community has said, continues to say and will always say:

“NO BUILD/NO FURTHER ACTION!”



WE DEMAND THAT THE MPO CONSIDER THESE PRIORITIES INSTEAD OF FURTHER INTERSTATE EXPANSION

Begin and rapidly finish the HART BRT study for Florida, Fowler, and Nebraska, and refresh plans for East-West BRT & South County BRT; fund and build true, gold standard Bus Rapid Transit on local arterial corridors

Finish the Heights Mobility Study, and set a rapid implementation date for study recommendations

Prioritize buying the CSX lines, and update study already performed

Prioritize all local **NON-INTERSTATE** Vision Zero improvements

Get to work on the Boulevard Tampa concept and present it as part of a cohesive long-term transit plan

Do not add more lanes to the interstate; Preserve the Floribraska exit

THE OVERALL GOAL: FDOT must work a plan that is enjoined with mass transit, complete streets and reducing emissions
